#### Abstract

This appendix contains the technical lemmas used in the proofs of the main theorems.


## SA Proofs

Throughout the proofs, we use $K$ to denote a generic finite constant that may change from line to line. For $p \geq 1$, let $\|\cdot\|_{p}$ denote the $L_{p}$ norm for random variables. For notational simplicity, we write $\sum_{t}$ in place of $\sum_{t=1}^{n}$.

## SA. 1 Technical lemmas for Theorem 1

Lemma S1. Under Assumptions 1 and 2, we have for any $R>0$,

\begin{aligned}
\sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left\|P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right\|^{2} & =O_{p}\left(\zeta_{1, n}^{2} m_{n} n^{-1}\right), \\
n^{-1} \sum_{t}\left\|P\left(\widehat{X}_{t}\right)-P\left(X_{t}^{\star}\right)\right\|^{2} & =O_{p}\left(\zeta_{1, n}^{2} m_{n} n^{-1}\right) .
\end{aligned}
$$

[^0]Proof. Fix some constant $\eta>0$. Since the variables $\left(L_{X, t}\right)_{1 \leq t \leq n}$ are $L_{p}$-bounded, we can use a maximal inequality to deduce $\mathbb{E}\left[\max _{1 \leq t \leq n}\left|L_{X, t}\right|\right] \leq n^{1 / p} \max _{1 \leq t \leq n}\left\|L_{X, t}\right\|_{p} \leq K n^{1 / p}$. Note that

\sup _{\theta \in B_{n}(R)} \max _{1 \leq t \leq n}\left\|X_{t}(\theta)-X_{t}^{\star}\right\| \leq K n^{-1 / 2} \max _{1 \leq t \leq n}\left|L_{X, t}\right|=O_{p}\left(n^{1 / p-1 / 2}\right) .
$$

Hence, there exists some constant $C>0$ such that

\mathbb{P}\left(\Omega_{n}^{c}\right)<\eta / 2, \quad \text { where } \quad \Omega_{n} \equiv\left\{\sup _{\theta \in B_{n}(R)} \max _{1 \leq t \leq n}\left\|X_{t}(\theta)-X_{t}^{\star}\right\| \leq C n^{1 / p-1 / 2}\right\}
$$

In particular, $X_{t}(\theta) \in \mathcal{X} \oplus C n^{1 / p-1 / 2}$ for all $t$ and $\theta \in B_{n}(R)$ in restriction to $\Omega_{n}$, and hence,

& \sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left\|P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right\|^{2} \\
& \quad=\sup _{\theta \in B_{n}(R)} n^{-1} \sum_{l=1}^{m_{n}} \sum_{t}\left|\partial p_{l}\left(\bar{X}_{\theta, t}\right)^{\top}\left(X_{t}(\theta)-X_{t}^{\star}\right)\right|^{2} \\
& \quad \leq \sup _{\theta \in B_{n}(R)} n^{-1} \sum_{l=1}^{m_{n}} \sum_{t}\left\|\partial p_{l}\left(\bar{X}_{\theta, t}\right)\right\|^{2}\left\|X_{t}(\theta)-X_{t}^{\star}\right\|^{2} \\
& \quad \leq K \zeta_{1, n}^{2} m_{n} n^{-1}\left(n^{-1} \sum_{t} L_{X, t}^{2}\right)=O_{p}\left(\zeta_{1, n}^{2} m_{n} n^{-1}\right),
\end{aligned}
$$

where $\bar{X}_{\theta, t}$ is some mean value between $X_{t}(\theta)$ and $X_{t}^{\star}$, the first inequality is by the CauchySchwarz inequality, and the second inequality is by Assumptions 1 and 2. Therefore, there exists some constant $K>0$ such that

\mathbb{P}\left(\left\{\sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left\|P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right\|^{2}>K \zeta_{1, n}^{2} m_{n} n^{-1}\right\} \cap \Omega_{n}\right)<\eta / 2 .
$$

Hence,

\begin{aligned}
& \mathbb{P}\left(\sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left\|P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right\|^{2}>K \zeta_{1, n}^{2} m_{n} n^{-1}\right) \\
& \quad \leq \mathbb{P}\left(\left\{\sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left\|P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right\|^{2}>K \zeta_{1, n}^{2} m_{n} n^{-1}\right\} \cap \Omega_{n}\right)+\mathbb{P}\left(\Omega_{n}^{c}\right)<\eta .
\end{aligned}
$$

This proves the first assertion of the lemma. Since $\hat{\theta}_{n}=\theta^{\star}+O_{p}\left(n^{-1 / 2}\right)$, the second assertion readily follows from the first.
Q.E.D.

Below, we denote

$$
\widehat{Q}_{n}(\theta) \equiv n^{-1} \sum_{t} P\left(X_{t}(\theta)\right) P\left(X_{t}(\theta)\right)^{\top} .
$$

Lemma S2. Suppose that Assumptions 1 and 2 hold. Then, we have for any $R>0$,

\sup _{\theta \in B_{n}(R)}\left\|\widehat{Q}_{n}(\theta)-Q_{n}\right\|_{S} & =O_{p}\left(\delta_{Q, n}+\zeta_{1, n} m_{n}^{1 / 2} n^{-1 / 2}\right)=o_{p}(1) \\
\left\|\widehat{Q}_{n}-Q_{n}\right\|_{S} & =O_{p}\left(\delta_{Q, n}+\zeta_{1, n} m_{n}^{1 / 2} n^{-1 / 2}\right)=o_{p}(1)
\end{aligned}
$$

Proof. Note that $\widehat{Q}_{n}^{\star}=\widehat{Q}_{n}\left(\theta^{\star}\right)$. By the triangle inequality,

\left\|\widehat{Q}_{n}(\theta)-\widehat{Q}_{n}^{\star}\right\| \leq & \left\|n^{-1} \sum_{t}\left(P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right)\left(P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right)^{\top}\right\| \\
& +2\left\|n^{-1} \sum_{t} P\left(X_{t}^{\star}\right)\left(P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right)^{\top}\right\| . \tag{S.1}
\end{align*}
$$

By the Cauchy-Schwarz inequality and Lemma S1, we have uniformly in $\theta \in B_{n}(R)$,

\begin{align*}
& \left\|n^{-1} \sum_{t}\left(P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right)\left(P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right)^{\top}\right\|^{2} \\
& \quad \leq\left(n^{-1} \sum_{l=1}^{m_{n}} \sum_{t}\left(p_{l}\left(X_{t}(\theta)\right)-p_{l}\left(X_{t}^{\star}\right)\right)^{2}\right)^{2}=O_{p}\left(\zeta_{1, n}^{4} m_{n}^{2} n^{-2}\right) . \tag{S.2}
\end{align*}
$$

In addition, we have uniformly in $\theta \in B_{n}(R)$,

$$
\begin{align*}
& \left\|n^{-1} \sum_{t} P\left(X_{t}^{\star}\right)\left(P\left(X_{t}(\theta)\right)-P\left(X_{t}^{\star}\right)\right)^{\top}\right\|^{2} \\
& \quad=\sum_{l=1}^{m_{n}}\left\|n^{-1} \sum_{t} P\left(X_{t}^{\star}\right)\left(p_{l}\left(X_{t}(\theta)\right)-p_{l}\left(X_{t}^{\star}\right)\right)\right\|^{2} \\
& \quad \leq \lambda_{\max }\left(\widehat{Q}_{n}^{\star}\right) \sum_{l=1}^{m_{n}} n^{-1} \sum_{t}\left(p_{l}\left(X_{t}(\theta)\right)-p_{l}\left(X_{t}^{\star}\right)\right)^{2}=O_{p}\left(\zeta_{1, n}^{2} m_{n} n^{-1}\right), \tag{S.3}
\end{align*}
$$

where the bound on the last line follows from Lemma S 1 and $\lambda_{\max }\left(\widehat{Q}_{n}^{\star}\right)=O_{p}(1)$, with the latter implied by Assumption 2. By (S.1), (S.2), and (S.3), we have uniformly in $\theta \in B_{n}(R)$,

\left\|\widehat{Q}_{n}(\theta)-\widehat{Q}_{n}^{\star}\right\| & =O_{p}\left(\zeta_{1, n}^{2} m_{n} n^{-1}+\zeta_{1, n} m_{n}^{1 / 2} n^{-1 / 2}\right) \\
& =O_{p}\left(\zeta_{1, n} m_{n}^{1 / 2} n^{-1 / 2}\right)=o_{p}(1)
\end{aligned}
$$

where the second line follows from $\zeta_{1, n} m_{n}^{1 / 2} n^{-1 / 2}=o(1)$ which is implied by Assumption 2(ii). The first assertion of the lemma thus follows from the estimate above and the assumption that $\left\|\widehat{Q}_{n}^{\star}-Q_{n}\right\|_{S}=O_{p}\left(\delta_{Q, n}\right)$. The second assertion then follows from $\hat{\theta}_{n}=\theta^{\star}+O_{p}\left(n^{-1 / 2}\right)$. Q.E.D.

Lemma S3. Under Assumption 1, we have for each $R>0$,

$$
\sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left(Z_{t+1}(\theta)-Z_{t+1}^{\star}\right)^{2}=O_{p}\left(n^{-1 / 2}\right)
$$

Proof. Fix any $R>0$. Note that for each $\theta \in B_{n}(R), f_{t}\left(\theta^{\star}\right)-R n^{-1 / 2} L_{t} \leq f_{t}(\theta) \leq f_{t}\left(\theta^{\star}\right)+$ $R n^{-1 / 2} L_{t}$, and hence,

\left|Z_{t+1}(\theta)-Z_{t+1}\left(\theta^{\star}\right)\right|^{2}=\left|1_{\left\{Y_{t+1} \leq f_{t}(\theta)\right\}}-1_{\left\{Y_{t+1} \leq f_{t}\left(\theta^{\star}\right)\right\}}\right| \leq U_{t}^{+}-U_{t}^{-}, \tag{S.4}
\end{equation*}
$$

where we set $U_{t}^{ \pm} \equiv 1_{\left\{Y_{t+1} \leq f_{t}\left(\theta^{\star}\right) \pm R n^{-1 / 2} L_{t}\right\}}$. Therefore,

$$
\begin{equation*}
\sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left(Z_{t+1}(\theta)-Z_{t+1}\left(\theta^{\star}\right)\right)^{2} \leq n^{-1} \sum_{t}\left(U_{t}^{+}-U_{t}^{-}\right) . \tag{S.5}
\end{equation*}
$$

Recall that $F_{t+1 \mid t}(\cdot)$ is the $\mathcal{F}_{t}$-conditional distribution function of $Y_{t+1}$. By Assumption 1,

$$
\begin{align*}
\mathbb{E}\left[U_{t}^{+}-U_{t}^{-} \mid \mathcal{F}_{t}\right] & =F_{t+1 \mid t}\left(f_{t}\left(\theta^{\star}\right)+R n^{-1 / 2} L_{t}\right)-F_{t+1 \mid t}\left(f_{t}\left(\theta^{\star}\right)-R n^{-1 / 2} L_{t}\right) \\
& \leq 2 R n^{-1 / 2} L_{t}^{2} . \tag{S.6}
\end{align*}
$$

Since $L_{t}$ is $L_{2}$-bounded, $\mathbb{E}\left[U_{t}^{+}-U_{t}^{-}\right] \leq K n^{-1 / 2}$. The assertion of the lemma then readily follows from this estimate and (S.5).

Lemma S4. Suppose that Assumptions 1 and 2 hold. Then, we have for any $R>0$,

$$
\sup _{\theta \in B_{n}(R)}\left\|n^{-1} \sum_{t} P\left(X_{t}(\theta)\right)\left(Z_{t+1}(\theta)-Z_{t+1}^{\star}\right)\right\|=O_{p}\left(n^{-1 / 2}+m_{n}^{1 / 2}\left(\zeta_{1, n} n^{-5 / 4}+\zeta_{0, n} n^{-3 / 4}\right)\right) .
$$

Proof. Step 1. By Lemma S2, $\sup _{\theta \in B_{n}(R)}\left\|\widehat{Q}_{n}(\theta)-Q_{n}\right\|=o_{p}(1)$. Since the eigenvalues of $Q_{n}$ are bounded from above and away from zero, we further deduce

\lambda_{\min }^{-1}\left(\widehat{Q}_{n}(\theta)\right)+\lambda_{\max }\left(\widehat{Q}_{n}(\theta)\right)=O_{p}(1), \quad \text { uniformly in } \theta \in B_{n}(R) . \tag{S.7}
\end{equation*}
$$

Recall that $\bar{Z}_{t+1}(\theta)=F_{t+1 \mid t}\left(f_{t}(\theta)\right)-q$ is the $\mathcal{F}_{t}$-conditional mean of $Z_{t+1}(\theta)$. Let $\widetilde{Z}_{t+1}(\theta) \equiv$ $Z_{t+1}(\theta)-\bar{Z}_{t+1}(\theta)$, which forms a martingale difference sequence with respect to $\mathcal{F}_{t}$ by construction. By the triangle inequality,

\begin{align*}
\sup _{\theta \in B_{n}(R)} & \left\|n^{-1} \sum_{t} P\left(X_{t}(\theta)\right)\left(Z_{t+1}(\theta)-Z_{t+1}^{\star}\right)\right\| \\
\leq & \sup _{\theta \in B_{n}(R)}\left\|n^{-1} \sum_{t} P\left(X_{t}(\theta)\right)\left(\bar{Z}_{t+1}(\theta)-\bar{Z}_{t+1}\left(\theta^{\star}\right)\right)\right\| \\
& \quad+\sup _{\theta \in B_{n}(R)}\left\|n^{-1} \sum_{t} P\left(X_{t}(\theta)\right)\left(\widetilde{Z}_{t+1}(\theta)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right)\right\| . \tag{S.8}
\end{align*}
$$

The first term on the majorant side of (S.8) can be bounded as follows

$$
\begin{aligned}
& \sup _{\theta \in B_{n}(R)}\left\|n^{-1} \sum_{t} P\left(X_{t}(\theta)\right)\left(\bar{Z}_{t+1}(\theta)-\bar{Z}_{t+1}\left(\theta^{\star}\right)\right)\right\|^{2} \\
& \quad \leq \sup _{\theta \in B_{n}(R)} \lambda_{\max }\left(\widehat{Q}_{n}(\theta)\right) \sup _{\theta \in B_{n}(R)} n^{-1} \sum_{t}\left(\bar{Z}_{t+1}(\theta)-\bar{Z}_{t+1}\left(\theta^{\star}\right)\right)^{2} \\
& \quad \leq O_{p}(1) \cdot \sup _{\theta \in B_{n}(R)}\left\{n^{-1} \sum_{t}\left(\left\|\partial_{\theta} \bar{Z}_{t+1}\left(\theta^{\star}\right)\right\|\left\|\theta-\theta^{\star}\right\|+\bar{L}_{t+1}\left\|\theta-\theta^{\star}\right\|^{2}\right)^{2}\right\} \\
& \quad=O_{p}\left(n^{-1}\right)
\end{aligned}
$$

where the first inequality is obtained by using the contraction property of least-square projections, the second inequality is due to Assumption 1, and the last line follows from the $L_{2}$-boundedness of $\left\|\partial_{\theta} \bar{Z}_{t}\left(\theta^{\star}\right)\right\|$ and $\bar{L}_{t}$. This estimate further implies that

\sup _{\theta \in B_{n}(R)}\left\|n^{-1} \sum_{t} P\left(X_{t}(\theta)\right)\left(\bar{Z}_{t+1}(\theta)-\bar{Z}_{t+1}\left(\theta^{\star}\right)\right)\right\|=O_{p}\left(n^{-1 / 2}\right)
$$

Hence, to prove the assertion of the lemma, it remains to show that the second term on the majorant side of (S.8) satisfies

\begin{equation*}
\sup _{\theta \in B_{n}(R)}\left\|n^{-1} \sum_{t} P\left(X_{t}(\theta)\right)\left(\widetilde{Z}_{t+1}(\theta)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right)\right\|=O_{p}\left(m_{n}^{1 / 2}\left(\zeta_{1, n} n^{-5 / 4}+\zeta_{0, n} n^{-3 / 4}\right)\right) \tag{S.9}
\end{equation*}
$$

Below, we prove (S.9) in two steps.
Step 2. For ease of notation, we set for each $l \in\left\{1, \ldots, m_{n}\right\}$,

$$
\pi_{l, n}(\theta) \equiv n^{-1 / 2} \sum_{t} p_{l}\left(X_{t}(\theta)\right)\left(\widetilde{Z}_{t+1}(\theta)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right), \quad \theta \in \Theta
$$

In this step, we establish the following technical estimate:

$$
\begin{equation*}
\left\|\pi_{l, n}\left(\theta_{1}\right)-\pi_{l, n}\left(\theta_{2}\right)\right\|_{p} \leq K\left(\zeta_{1, n} n^{-1 / 2}+\zeta_{0, n}\right)\left\|\theta_{1}-\theta_{2}\right\|^{1 / 2}, \quad \text { for } \theta_{1}, \theta_{2} \in B_{n}(R) \tag{S.10}
\end{equation*}
$$

Recall that $\widetilde{Z}_{t+1}(\theta)=Z_{t+1}(\theta)-\mathbb{E}\left[Z_{t+1}(\theta) \mid \mathcal{F}_{t}\right]$. It is then easy to see that

$$
\mathbb{E}\left[\left(\widetilde{Z}_{t+1}(\theta)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right)^{2} \mid \mathcal{F}_{t}\right] \leq \mathbb{E}\left[\left(Z_{t+1}(\theta)-Z_{t+1}\left(\theta^{\star}\right)\right)^{2} \mid \mathcal{F}_{t}\right]
$$

By (S.4) and (S.6), the majorant side of the above inequality can be further bounded by $K n^{-1 / 2} L_{t}^{2}$ uniformly in $\theta \in B_{n}(R)$. Hence,

$$
\begin{equation*}
\mathbb{E}\left[\left(\widetilde{Z}_{t+1}(\theta)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right)^{2} \mid \mathcal{F}_{t}\right] \leq K n^{-1 / 2} L_{t}^{2} \tag{S.11}
\end{equation*}
$$

For $\theta_{1}, \theta_{2} \in B_{n}(R)$, we can decompose

$$
\begin{align*}
\pi_{l, n}\left(\theta_{1}\right)-\pi_{l, n}\left(\theta_{2}\right)= & n^{-1 / 2} \sum_{t}\left[p_{l}\left(X_{t}\left(\theta_{1}\right)\right)-p_{l}\left(X_{t}\left(\theta_{2}\right)\right)\right]\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right) \\
& +n^{-1 / 2} \sum_{t} p_{l}\left(X_{t}\left(\theta_{2}\right)\right)\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta_{2}\right)\right) \tag{S.12}
\end{align*}
$$

We now derive $L_{p}$-bounds for the two terms on the right-hand side of (S.12). By (S.11), Burkholder's inequality, and Hölder's inequality, we have

\begin{aligned}
& \mathbb{E}\left[\mid n^{-1 / 2} \sum_{t}\left[\left.\left(p_{l}\left(X_{t}\left(\theta_{1}\right)\right)-p_{l}\left(X_{t}\left(\theta_{2}\right)\right)\right]\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right)\right|^{p}\right]\right. \\
& \quad \leq K \mathbb{E}\left[\mid n^{-1} \sum_{t}\left[\left.\left(p_{l}\left(X_{t}\left(\theta_{1}\right)\right)-p_{l}\left(X_{t}\left(\theta_{2}\right)\right)\right]^{2} n^{-1 / 2} L_{t}^{2}\right|^{p / 2}\right]\right. \\
& \quad \leq K n^{-p / 4} \mathbb{E}\left[\left|\zeta_{1, n}^{2}\left\|\theta_{1}-\theta_{2}\right\|^{2}\left(n^{-1} \sum_{t} L_{X, t}^{2} L_{t}^{2}\right)\right|^{p / 2}\right] \\
& \quad \leq K n^{-p / 4} \zeta_{1, n}^{p} \mathbb{E}\left[n^{-1} \sum_{t} L_{X, t}^{p} L_{t}^{p}\right]\left\|\theta_{1}-\theta_{2}\right\|^{p} .
\end{aligned}
$$

Since $\mathbb{E}\left[L_{X, t}^{p} L_{t}^{p}\right] \leq K$ by Assumption 1, we can bound the $L_{p}$-norm of the first term in the decomposition (S.12) as follows

\| n^{-1 / 2} \sum_{t}\left[\left(p_{l}\left(X_{t}\left(\theta_{1}\right)\right)-p_{l}\left(X_{t}\left(\theta_{2}\right)\right)\right]\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta^{\star}\right)\right)\left\|_{p} \leq K n^{-1 / 4} \zeta_{1, n}\right\| \theta_{1}-\theta_{2} \| .\right. \tag{S.13}
\end{equation*}
$$

Turning to the second term in the decomposition (S.12), we note that

$$
\left(Z_{t+1}\left(\theta_{1}\right)-Z_{t+1}\left(\theta_{2}\right)\right)^{2} \leq 1_{\left\{Y_{t+1} \leq f_{t}\left(\theta_{1}\right)+\left|f_{t}\left(\theta_{1}\right)-f_{t}\left(\theta_{2}\right)\right|\right\}}-1_{\left\{Y_{t+1} \leq f_{t}\left(\theta_{1}\right)-\left|f_{t}\left(\theta_{1}\right)-f_{t}\left(\theta_{2}\right)\right|\right\}} .
$$

Hence,

$$
\begin{equation*}
\mathbb{E}\left[\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta_{2}\right)\right)^{2} \mid \mathcal{F}_{t}\right] \leq 2 L_{t}\left|f_{t}\left(\theta_{1}\right)-f_{t}\left(\theta_{2}\right)\right| \leq 2 L_{t}^{2}\left\|\theta_{1}-\theta_{2}\right\| \tag{S.14}
\end{equation*}
$$

By (S.14), Burkholder's inequality, and Hölder's inequality,

$$
\begin{aligned}
& \mathbb{E}\left[\left|n^{-1 / 2} \sum_{t} p_{l}\left(X_{t}\left(\theta_{2}\right)\right)\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta_{2}\right)\right)\right|^{p}\right] \\
& \quad \leq K \mathbb{E}\left[\left|n^{-1} \sum_{t} p_{l}\left(X_{t}\left(\theta_{2}\right)\right)^{2} \mathbb{E}\left[\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta_{2}\right)\right)^{2} \mid \mathcal{F}_{t}\right]\right|^{p / 2}\right] \\
& \quad \leq K\left\|\theta_{1}-\theta_{2}\right\|^{p / 2} \mathbb{E}\left[\left|n^{-1} \sum_{t} p_{l}\left(X_{t}\left(\theta_{2}\right)\right)^{2} L_{t}^{2}\right|^{p / 2}\right] \\
& \quad \leq K \zeta_{0, n}^{p}\left\|\theta_{1}-\theta_{2}\right\|^{p / 2} n^{-1} \sum_{t} \mathbb{E}\left[L_{t}^{p}\right] \leq K \zeta_{0, n}^{p}\left\|\theta_{1}-\theta_{2}\right\|^{p / 2}
\end{aligned}
$$

Hence,

\begin{equation*}
\left\|n^{-1 / 2} \sum_{t} p_{l}\left(X_{t}\left(\theta_{2}\right)\right)\left(\widetilde{Z}_{t+1}\left(\theta_{1}\right)-\widetilde{Z}_{t+1}\left(\theta_{2}\right)\right)\right\|_{p} \leq K \zeta_{0, n}\left\|\theta_{1}-\theta_{2}\right\|^{1 / 2} \tag{S.15}
\end{equation*}
$$

Since $\left\|\theta_{1}-\theta_{2}\right\| \leq R n^{-1 / 2}$, the assertion in (S.10) readily follows from (S.13) and (S.15).
Step 3. We shall use a chaining argument to establish (S.9). Construct nested sets $\Theta_{0, n} \subset$ $\Theta_{1, n} \cdots \subset B_{n}(R)$ such that $\Theta_{0, n}=\left\{\theta^{\star}\right\}$ and for each $j \geq 1, \Theta_{j, n}$ is a maximal set of points such that each pair of distinct elements in $\Theta_{j, n}$ has distance greater than $R n^{-1 / 2} 2^{-j}$. Note that the number of points in $\Theta_{j}$ is less than $C\left(2^{j}\right)^{d_{\theta}}$ for some constant $C>0$ that does not depend on $j$. Link every point $\theta_{j+1} \in \Theta_{j+1}$ to a unique $\theta_{j} \in \Theta_{j}$ such that $\left\|\theta_{j+1}-\theta_{j}\right\| \leq R n^{-1 / 2} 2^{-j}$. Then for any $J \geq 0$ and $\theta_{J+1} \in \Theta_{J+1}$, we can construct a chain $\theta_{J+1}, \ldots, \theta_{0}$ to $\theta_{0}=\theta^{\star}$, and hence, by the triangle inequality

where, for each $j$, the maximum is taken over all links $\left(\theta_{j+1}, \theta_{j}\right)$ from $\Theta_{j+1}$ to $\Theta_{j}$ (with the total number less than $\left.C\left(2^{j+1}\right)^{d_{\theta}}\right)$. We then observe

& \leq K \sum_{j=0}^{J}\left(2^{j}\right)^{d_{\theta} / p}\left(\zeta_{1, n} n^{-1 / 2}+\zeta_{0, n}\right)\left(R n^{-1 / 2} 2^{-j}\right)^{1 / 2} \\
& \leq K\left(\zeta_{1, n} n^{-3 / 4}+\zeta_{0, n} n^{-1 / 4}\right)
\end{aligned}
$$

where the first inequality is by (S.16); the second inequality is by a maximal inequality under the $L_{p}$-norm; the third inequality follows from (S.10); and the last inequality holds because $\sum_{j}\left(2^{j}\right)^{d_{\theta} / p}\left(2^{-j}\right)^{1 / 2}<\infty$ as implied by $p>2 d_{\theta}$. Since the stochastic process $\pi_{l, n}(\theta)$ indexed by $\theta$ is separable, by letting $J \rightarrow \infty$, we further have

The assertion in (S.9) then readily follows from this estimate and (S.17).

\end{aligned}

where the first inequality is by Burkholder's inequality and the boundedness of $u_{t}^{\star}$, and the second line follows from Assumptions 1 and 2. Hence,

\end{aligned}

Sending $J \rightarrow \infty$, we further deduce

& +\widehat{Q}_{n}^{-1}\left(n^{-1} \sum_{t} P\left(\widehat{X}_{t}\right)\left(\widehat{Z}_{t+1}-Z_{t+1}^{\star}\right)\right) . \tag{S.21}
\end{align*}

It remains to bound the four terms on the right-hand side of this decomposition.

& +2 \lambda_{\min }^{-1}\left(\widehat{Q}_{n}\right) n^{-1} \sum_{t}\left(h\left(\widehat{X}_{t}\right)-h\left(X_{t}^{\star}\right)\right)^{2} .
\end{aligned}

& \quad=\left(\sum_{l=1}^{m_{n}}\left\|n^{-1} \sum_{t} u_{t}^{\star 2} P\left(X_{t}^{\star}\right)\left(p_{l}\left(\widehat{X}_{t}\right)-p_{l}\left(X_{t}^{\star}\right)\right)\right\|^{2}\right)^{1 / 2} \\
& \quad \leq\left(\sum_{l=1}^{m_{n}} \lambda_{\max }\left(\widehat{Q}_{n}^{\star}\right) n^{-1} \sum_{t}\left\|u_{t}^{\star 2}\left(p_{l}\left(\widehat{X}_{t}\right)-p_{l}\left(X_{t}^{\star}\right)\right)\right\|^{2}\right)^{1 / 2} \\
& \quad \leq O_{p}(1) \cdot\left(n^{-1} \sum_{t}\left\|P\left(\widehat{X}_{t}\right)-P\left(X_{t}^{\star}\right)\right\|^{2}\right)^{1 / 2} \\
& \quad=O_{p}\left(\zeta_{1, n} m_{n}^{1 / 2} n^{-1 / 2}\right) . \tag{S.30}
\end{align*}

\end{equation*}

which further implies that $\left\|n^{-1} \sum_{t} P\left(X_{t}^{\star}\right) \eta_{t}\right\|=O_{p}\left(m_{n}^{1 / 2} n^{-1 / 2}\right)$. Hence,

& \leq O_{p}(1)\left\|\widehat{Q}_{n}-Q_{n}\right\|_{S}\left(n^{-1} \sum_{t}\left\|g\left(X_{t}^{\star}\right)\right\|^{2}\right)^{1 / 2} \\
& =O_{p}\left(\delta_{Q, n}+\zeta_{1, n} m_{n}^{1 / 2} n^{-1 / 2}\right)=o_{p}\left((\log n)^{-1 / 2}\right) . \tag{S.55}

& =n^{-2} \sum_{t} \sum_{l_{1}, l_{2}=1}^{m_{n}}\left(p_{l_{1}}\left(\widehat{X}_{t}\right) p_{l_{2}}\left(\widehat{X}_{t}\right)\left(\widehat{Z}_{t+1}-P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{2}\right)^{2} \\
& =n^{-2} \sum_{t}\left\|P\left(\widehat{X}_{t}\right)\right\|^{4} \widehat{u}_{t}^{4} . \tag{S.68}
\end{align*}
$$

Next, we observe that

$$
\begin{align*}
& n^{-2} \sum_{t}\left\|P\left(\widehat{X}_{t}\right)\right\|^{4} \widehat{u}_{t}^{4} \\
& \quad \leq K n^{-2} \sum_{t}\left\|P\left(\widehat{X}_{t}\right)\right\|^{4}\left(u_{t}^{\star}\right)^{4}+K n^{-2} \sum_{t}\left\|P\left(\widehat{X}_{t}\right)\right\|^{4}\left(\widehat{u}_{t}-u_{t}^{\star}\right)^{4} \\
& \quad \leq K \zeta_{0, n}^{2} m_{n} n^{-2} \sum_{t}\left\|P\left(\widehat{X}_{t}\right)\right\|^{2}+\zeta_{0, n}^{4} m_{n}^{2} n^{-2} \sum_{t}\left(\widehat{u}_{t}-u_{t}^{\star}\right)^{4} \\
& \quad=O_{p}\left(\zeta_{0, n}^{2} m_{n}^{2} n^{-1}\right)+O_{p}\left(\zeta_{0, n}^{4} m_{n}^{2} n^{-1}\right) O_{p}\left(n^{-1 / 2}+\zeta_{0, n}^{2} m_{n} \delta_{b, n}^{4}\right) \\
& \quad=O_{p}\left(\zeta_{0, n}^{2} m_{n}^{2} n^{-1}\right), \tag{S.69}
\end{align*}
$$

where the second inequality follows from $\left|u_{t}^{\star}\right| \leq K$ and $\left\|P\left(X_{t}\right)\right\| \leq \zeta_{0, n} m_{n}^{1 / 2}$, the first equality follows from (S.46), and the last line is implied by the maintained rate conditions in Assumption 2. Therefore,

\left\|R_{1, n}-\widehat{A}_{n}\right\|=O_{p}\left(\zeta_{0, n} m_{n} n^{-1 / 2}\right) \tag{S.70}
\end{equation*}

Next, we analyze

R_{2, n} \equiv n^{-1} \sum_{t} P\left(\widehat{X}_{t}^{*}\right) P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{Z}_{t+1}^{*}-P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{b}_{n}\right)\left(P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{b}_{n}^{*}-\widehat{b}_{n}\right)\right) .
$$

Consider any $a_{n} \in \mathbb{R}^{m_{n}}$ with $\left\|a_{n}\right\|=1$. Observe that

a_{n}^{\top} R_{2, n}^{2} a_{n} & =\left\|n^{-1} \sum_{t} P\left(\widehat{X}_{t}^{*}\right) P\left(\widehat{X}_{t}^{*}\right)^{\top} a_{n}\left(\widehat{Z}_{t+1}^{*}-P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{b}_{n}\right)\left(P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{b}_{n}^{*}-\widehat{b}_{n}\right)\right)\right\|^{2} \\
& \leq \lambda_{\max }\left(\widehat{Q}_{n}^{*}\right) n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}^{*}\right)^{\top} a_{n}\right)^{2}\left(\widehat{Z}_{t+1}^{*}-P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{b}_{n}\right)^{2}\left(P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{b}_{n}^{*}-\widehat{b}_{n}\right)\right)^{2} \\
& \leq \lambda_{\max }\left(\widehat{Q}_{n}^{*}\right) \max _{1 \leq t \leq n}\left\|P\left(\widehat{X}_{t}^{*}\right)\right\|^{2}\left\|\widehat{b}_{n}^{*}-\widehat{b}_{n}\right\|^{2} n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}^{*}\right)^{\top} a_{n}\right)^{2}\left(\widehat{Z}_{t+1}^{*}-P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{b}_{n}\right)^{2} \\
& \leq O_{p}\left(\zeta_{0, n}^{2} m_{n}\left(\delta_{b, n}^{*}\right)^{2}\right) \max _{1 \leq t \leq n}\left(\widehat{Z}_{t+1}^{*}-P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{b}_{n}\right)^{2}, \tag{S.71}
\end{align*}
$$

where the last line follows from Lemma S10. In addition, since $\widehat{Z}_{t+1}^{*}-h\left(\widehat{X}_{t}^{*}\right)$ is bounded and $\max _{1 \leq t \leq n}\left|h\left(\widehat{X}_{t}^{*}\right)-P\left(\widehat{X}_{t}^{*}\right)^{\top} b_{n}^{\star}\right|=o_{p}(1)$,

\begin{align*}
\max _{1 \leq t \leq n}\left|\widehat{Z}_{t+1}^{*}-P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{b}_{n}\right| \leq & \max _{1 \leq t \leq n}\left|\widehat{Z}_{t+1}^{*}-h\left(\widehat{X}_{t}^{*}\right)\right|+\max _{1 \leq t \leq n}\left|h\left(\widehat{X}_{t}^{*}\right)-P\left(\widehat{X}_{t}^{*}\right)^{\top} b_{n}^{\star}\right| \\
& +\max _{1 \leq t \leq n}\left|P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{b}_{n}-b_{n}^{\star}\right)\right| \\
= & O_{p}\left(1+\zeta_{0, n} m_{n}^{1 / 2} \delta_{b, n}\right)=O_{p}(1) . \tag{S.72}
\end{align*}
$$

Hence, (S.71) further implies that

\begin{equation*}
\left\|R_{2, n}\right\|_{S}=O_{p}\left(\zeta_{0, n} m_{n}^{1 / 2} \delta_{b, n}^{*}\right) \tag{S.73}
\end{equation*}
$$

It remains to study the term

R_{3, n} \equiv n^{-1} \sum_{t} P\left(\widehat{X}_{t}^{*}\right) P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{b}_{n}^{*}-\widehat{b}_{n}\right)\right)^{2}
$$

Consider any $a_{n} \in \mathbb{R}^{m_{n}}$ with $\left\|a_{n}\right\|=1$. Then by the Cauchy-Schwarz inequality

\begin{aligned}
a_{n}^{\top} R_{3, n}^{2} a_{n} & =\left\|n^{-1} \sum_{t} P\left(\widehat{X}_{t}^{*}\right) P\left(\widehat{X}_{t}^{*}\right)^{\top} a_{n}\left(P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{b}_{n}^{*}-\widehat{b}_{n}\right)\right)^{2}\right\|^{2} \\
& \leq \lambda_{\max }\left(\widehat{Q}_{n}^{*}\right) n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}^{*}\right)^{\top} a_{n}\right)^{2}\left(P\left(\widehat{X}_{t}^{*}\right)^{\top}\left(\widehat{b}_{n}^{*}-\widehat{b}_{n}\right)\right)^{4} \\
& \leq\left(\lambda_{\max }\left(\widehat{Q}_{n}^{*}\right)\right)^{2} \max _{1 \leq t \leq n}\left\|P\left(\widehat{X}_{t}^{*}\right)\right\|^{4}\left\|\widehat{b}_{n}^{*}-\widehat{b}_{n}\right\|^{4} \\
& \leq O_{p}\left(\zeta_{0, n}^{4} m_{n}^{2}\left(\delta_{b, n}^{*}\right)^{4}\right),
\end{aligned}
$$

where the last line follows from (S.62) and Lemma S10. Hence,

$$
\begin{equation*}
\left\|R_{3, n}\right\|_{S}=O_{p}\left(\zeta_{0, n}^{2} m_{n} \delta_{b, n}^{* 2}\right) \tag{S.74}
\end{equation*}
$$

Finally, collecting the estimates in (S.70), (S.73), and (S.74), we get

\begin{aligned}
\left\|\widehat{A}_{n}^{*}-\widehat{A}_{n}\right\|_{S} & \leq\left\|R_{1, n}-\widehat{A}_{n}\right\|_{S}+2\left\|R_{2, n}\right\|_{S}+\left\|R_{3, n}\right\|_{S} \\
& =O_{p}\left(\zeta_{0, n} m_{n} n^{-1 / 2}+\zeta_{0, n} m_{n}^{1 / 2} \delta_{b, n}^{*}+\zeta_{0, n}^{2} m_{n} \delta_{b, n}^{* 2}\right) \\
& =O_{p}\left(\zeta_{0, n} m_{n}^{1 / 2} \delta_{b, n}^{*}\right)
\end{aligned}
$$

The assertions of the lemma then follows from the definition of $\delta_{b, n}^{*}$ in Lemma S10, and the fact that $\zeta_{0, n}^{2} \log \left(m_{n}\right)^{1 / 2} m_{n} n^{-1 / 2}=o(1)$ which is implied by the maintained rate conditions in Assumption 2.
Q.E.D.

Lemma S12. Suppose that Assumptions 1 and 2 hold. Then under the null hypothesis,

\left\|\widehat{H}_{n}^{*}-\widehat{A}_{n}\right\|_{S}=O_{p}\left(\zeta_{0, n} m_{n} n^{-1 / 2}\right)

where $\widehat{H}_{n}^{*} \equiv \mathbb{E}^{*}\left[\left(\widehat{Z}_{t+1}^{*}\right)^{2} P\left(\widehat{X}_{t}^{*}\right) P\left(\widehat{X}_{t}^{*}\right)^{\top}\right]-\mathbb{E}^{*}\left[\widehat{Z}_{t+1}^{*} P\left(\widehat{X}_{t}^{*}\right)\right] \mathbb{E}^{*}\left[P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{Z}_{t+1}^{*}\right]$.
Proof. Note that

Under the null hypothesis, $h(x)=0$ and $b_{n}^{\star}=0$. By (S.20) and Lemma S6,

\widehat{Q}_{n} \widehat{b}_{n}=O_{p}\left(m_{n}^{1 / 2} n^{-1 / 2}\right), \tag{S.76}
\end{equation*}

which together with (S.75) implies that

\left\|\mathbb{E}^{*}\left[\widehat{Z}_{t+1}^{*} P\left(\widehat{X}_{t}^{*}\right)\right] \mathbb{E}^{*}\left[P\left(\widehat{X}_{t}^{*}\right)^{\top} \widehat{Z}_{t+1}^{*}\right]\right\|=O_{p}\left(m_{n} n^{-1}\right) \tag{S.77}
\end{equation*}
$$

Since $\widehat{u}_{t}=\widehat{Z}_{t+1}-P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}$,

\mathbb{E}^{*} & {\left[\left(\widehat{Z}_{t+1}^{*}\right)^{2} P\left(\widehat{X}_{t}^{*}\right) P\left(\widehat{X}_{t}^{*}\right)^{\top}\right]-\widehat{A}_{n} } \\
& =n^{-1} \sum_{t}\left(\widehat{Z}_{t+1}\right)^{2} P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top}-\widehat{A}_{n} \\
& =n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}+\widehat{u}_{t}\right)^{2} P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top}-\widehat{A}_{n} \\
& =n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{2} P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top}+2 n^{-1} \sum_{t} \widehat{u}_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right) P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top} . \tag{S.78}
\end{align*}

Let $a_{n} \in \mathbb{R}^{m_{n}}$ be such that $\left\|a_{n}\right\|=1$. By Assumption 2, (S.20), and (S.76),

& a_{n}^{\top}\left(n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{2} P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top}\right)^{2} a_{n} \\
& \quad=\left\|n^{-1} \sum_{t} P\left(\widehat{X}_{t}\right)\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{2}\left(P\left(\widehat{X}_{t}\right)^{\top} a_{n}\right)\right\|^{2} \\
& \quad \leq \lambda_{\max }\left(\widehat{Q}_{n}\right) n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{4}\left(P\left(\widehat{X}_{t}\right)^{\top} a_{n}\right)^{2} \\
& \quad \leq\left(\lambda_{\max }\left(\widehat{Q}_{n}\right)\right)^{2} \max _{1 \leq t \leq n}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{4} \\
& \quad \leq\left(\lambda_{\max }\left(\widehat{Q}_{n}\right)\right)^{2} \max _{1 \leq t \leq n}\left\|P\left(\widehat{X}_{t}\right)\right\|^{4}\left\|\widehat{b}_{n}\right\|^{4}=O_{p}\left(\zeta_{0, n}^{4} m_{n}^{4} n^{-2}\right),
\end{aligned}

which implies that

\left\|n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{2} P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top}\right\|_{S}=O_{p}\left(\zeta_{0, n}^{2} m_{n}^{2} n^{-1}\right) \tag{S.79}
\end{equation*}

Turning to the second term in (S.78), we note that by (S.20), Lemma S7, and (S.76), we have

& a_{n}^{\top}\left(n^{-1} \sum_{t} \widehat{u}_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right) P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top}\right)^{2} a_{n} \\
& \quad=\left\|n^{-1} \sum_{t} P\left(\widehat{X}_{t}\right) \widehat{u}_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)\left(P\left(\widehat{X}_{t}\right)^{\top} a_{n}\right)\right\|^{2} \\
& \quad \leq \lambda_{\max }\left(\widehat{Q}_{n}\right) n^{-1} \sum_{t}\left(P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n}\right)^{2}\left(\widehat{u}_{t} P\left(\widehat{X}_{t}\right)^{\top} a_{n}\right)^{2} \\
& \quad \leq \lambda_{\max }\left(\widehat{Q}_{n}\right) \lambda_{\max }\left(\widehat{A}_{n}\right) \max _{1 \leq t \leq n}\left\|P\left(\widehat{X}_{t}\right)\right\|^{2}\left\|\widehat{b}_{n}\right\|^{2}=O_{p}\left(\zeta_{0, n}^{2} m_{n}^{2} n^{-1}\right), \tag{S.80}
\end{align*}
$$

which implies that

\begin{equation*}
\left\|n^{-1} \sum_{t} \widehat{u}_{t} P\left(\widehat{X}_{t}\right)^{\top} \widehat{b}_{n} P\left(\widehat{X}_{t}\right) P\left(\widehat{X}_{t}\right)^{\top}\right\|_{S}=O_{p}\left(\zeta_{0, n} m_{n} n^{-1 / 2}\right) . \tag{S.81}
\end{equation*}
$$

The assertion of the lemma then follows from (S.77), (S.78), (S.79), and (S.81).
