Course Description

The capstone seminar is a chance to take some of the core concepts you've learned in previous PPE courses and apply them to specific topics. The class is also an opportunity for you to write a concise research paper on a PPE-related topic of your choice. In the first part of the semester, we'll discuss the readings below. In the second part, you will present work in progress and get feedback from your peers. Each student will be assigned a time slot to present a chunk of their research paper, or talk about a book chapter or article that is central to their paper. Final papers will be submitted on the last day of class, and should be about 15 pages long.
